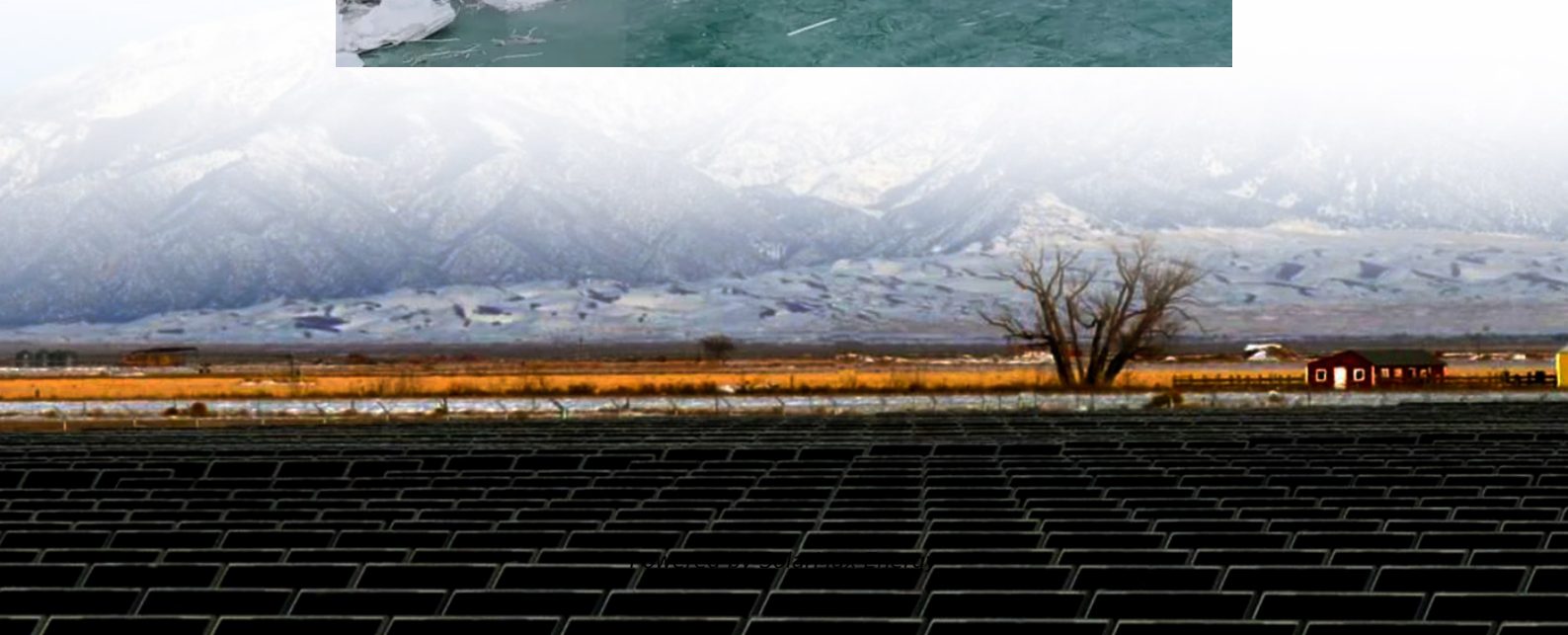

Overview

What if goods are prohibited in Turkmenistan?

1. Goods prohibited, under Turkmenistan legislation, from import into the customs territory of Turkmenistan, are subject to immediate removal from the customs territory of Turkmenistan unless otherwise specified by this Code and normative legal acts of Turkmenistan. Export (removal) of the above-mentioned goods shall be made by the carrier.

Can Turkmenistan import goods?

Goods restricted for import into the customs territory of Turkmenistan are allowed to import (and in cases stipulated by this Code - released by the customs authority), subject to terms and conditions prescribed by Turkmenistan legislation or international treaties of Turkmenistan. 2.

When are Turkmen goods considered under customs control?

Turkmen goods and vehicles are considered to be under customs control when they are exported from the customs territory of Turkmenistan since the adoption of the customs declaration or action directly aimed at the export of goods from the customs territory of Turkmenistan and before crossing the customs border of Turkmenistan. 3.

What are the customs regulations of Turkmenistan?

Customs regulations consist of the Customs Code of Turkmenistan, Tax Code of Turkmenistan (on excises) and a number of by-laws and presidential resolutions, particularly: #9925 of July 27, 2008 (import and export customs duties). Is temporary export allowed in Turkmenistan?

Temporary export is permitted provided that the temporarily exported goods can be identified by the customs authorities in their re-importation, except



cases where under international treaties of Turkmenistan, temporarily imported goods may be replaced by the same type of goods.

How do customs authorities identify Turkmen goods declared for export?

At the request of the declarant, the customs authorities shall identify Turkmen goods declared for export from the customs territory of Turkmenistan, in the place of its declaration. Article 338. Additional authority of customs authorities in the detection of goods illegally imported into the customs territory of Turkmenistan
